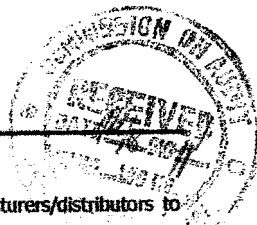

The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, performance Security, Evaluation of Bids, Post-Qualification and award of Contract shall be governed by the pertinent provisions of RA 9184 and its Implementing Rules and Regulations (IRR).


The schedule of BAC activities are as follows:

The BAC will issue to prospective bidders Bid Documents at Office of the BAC Secretariat, Municipal Hall, Duero, Bohol and upon their payment of non-refundable amount of P500.00 for each project to the Municipal Treasurer's Office, Duero, Bohol. Prospective Bidders shall submit Eligibility Check by the BAC at the same address.

The Municipal Government of Duero, Bohol assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of their bids.
