Section 1. INVITATION TO BID

The Municipality of Duero, Bohol, through its Bids and Awards Committee (BAC), invites suppliers/manufacturers/distributors to apply for eligibility and to bid if found eligible, to bid for the project:

Prospective bidders should have experience in undertaking a similar project within the last 2 years with an amount of at least 50% of the proposed project for bidding. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, performance Security, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of RA 9184 and its Implementing Rules and Regulations (IRR).


The schedule of BAC activities are as follows:

The BAC will issue to prospective bidders Bid Documents at Office of the BAC Secretariat, Municipal Hall, Duero, Bohol and upon their payment of non-refundable amount of P5,000.00 for the project to the Municipal Treasurer's Office, Duero, Bohol. Prospective Bidders shall submit Eligibility Check by the BAC at the same address.
