Section 1. INVITATION TO BID

The Municipality of Duero, Bohol, through its Bids and Awards Committee (BAC), invites suppliers/manufacturers/distributors to apply for eligibility and to bid if found eligible, to bid for the project:

(1) Name of Project : **REHABILITATION OF TINAGO-PILPILON ACCESS ROAD**
Location : **Taytay, Duero, Bohol**
Brief Description : **Concreting of 2 kilometer access road at 3 meters wide**
Estimated Budget for the Contract (EBC) : **P 7,406,500.00**
Source of Fund : **Asian Development Bank (ADB)/Counterpart of Bohol Provincial Government and LGU Duero**
Contract Duration : **160 working days**

Prospective bidders should have experience in undertaking a similar project within the last 5 years with an amount of at least 50% of the proposed project for bidding. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, performance Security, Evaluation of Bids, Post-Qualification and award of Contract shall be governed by the pertinent provisions of RA 9184 and its Implementing Rules and Regulations (IRR).
